Immediately prior to the completion of the Issuer's initial public offering of common stock on July 2, 2021, each share of Series A convertible preferred stock and Series A-1 convertible preferred stock automatically converted into one share of common stock without payment or further consideration and has no expiration date.
2. The securities are held of record by Anderson Investments Pte. Ltd. ("Anderson Investments"), which is a direct wholly-owned subsidiary of Thomson Capital Pte. Ltd. ("Thomson Capital"). Thomson Capital is a direct wholly-owned subsidiary of Tembusu Capital Pte. Ltd. ("Tembusu Capital"), which in turn is a direct wholly-owned subsidiary of Temasek Holdings (Private) Limited ("Temasek Holdings"). Thomson Capital, Tembusu Capital and Temasek Holdings may therefore be deemed to have or share beneficial ownership of the securities held by Anderson Investments.
3. The securities are held of record by Aranda Investments Pte. Ltd. ("Aranda Investments"), which is an indirect wholly-owned subsidiary of Temasek Holdings. Temasek Holdings may therefore be deemed to have or share beneficial ownership of the securities held by Aranda Investments.
